### **Invoicing:**

The partnership fee will be invoiced once Norwegian Energy Partners has received the partnership form duly signed by authorized personnel in the company.

A yearly invoice will be sent in January each year. Due date will be 30 days from the invoicing date.

The annual invoice is based on company information given by the company. Please attach for the application and invoicing process:

1. A copy of certificate of incorporation from the public registry,
2. Audited financial statement from the last 2 years.

### **Termination:**

Partnership is automatically renewed (and an invoice issued with automatic due date) unless it is cancelled in writing by received written notice before *30th June* (more than 6 months prior to the annual renewal date).

### **Market Information:**

Partner companies will have access to market information including an annual market report, country and market reports, priority projects, presentations etc.

*Market information is restricted to partners only and distribution to third parties is strictly prohibited!*
