


Offshore Wind Delegation Business mission to Taiwan

Norwegian delegation October 19th – 21st 2022 Taiwan

Taiwan ends quarantine for arrivals after 15th October!!

Open to entry for visa-free and non-visa-free countries from 29 September 2022



Offshore wind in Taiwan

Taiwan is one of the fastest growing offshore wind markets in Asia and at the same time possibly the most accessible one. Most of global offshore wind developers have established in Taiwan market with confidence and optimism in Taiwan's determination to achieve energy transformation goals and Net-Zero emission targets by 2050. More international and domestic industrial players are actively entering round 3 market auction in Taiwan.

Taiwanese offshore wind industry is growing fast and looking for cooperation with foreign companies with knowledge and solutions for the entire value chain especially when floating wind projects potentially becoming a better solution in the deeper water zone in round 3. The Norwegian offshore and maritime expertise can play key role in the future development of offshore wind in Taiwan, NORWEP offshore wind delegation to Taiwan aim to open more business opportunities for NORWEP Partners in Taiwan's round 3 project of 15GW.

Who should attend?

Norwegian companies operating within the offshore wind sector: developers, EPIC, vessel providers, planning and design consultancies, marine/offshore construction, transport and logistics, installation, sub suppliers to major developers, operation and maintenance.

NORWEP activities during business seeking mission to Taiwan We are planning B2B meetings for NORWEP partners with support from Taiwan's authorities. There will be intensive meetings with developers, industrial key suppliers, fabrication yards and installation companies as well as consultants and advisors of importance.
